The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I. NAME

Earlier this month, I spoke with a representative in the dissolution division regarding procedural issues relevant to the following situation.

Moor Systems International, Inc. was incorporated on March 14, 1995, by six incorporators: Dennis Johnson, Donna Johnson, Judith Weaver, Jacques De'Marques Frank Ellis, and Christie King. As of this date, Moor Systems International, Inc. has commenced business. This corporation has filed for dissolution. One of the original incorporators, Dennis Johnson, would like to reincorporate a business using the same name, Moor Systems International, Inc. According to the state representative that I spoke with, this name may be used by a new corporation without waiting 120 days if the incorporator includes an affidavit attesting that the new corporation will not file for dissolution.
