Name

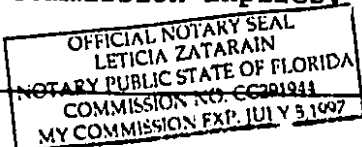

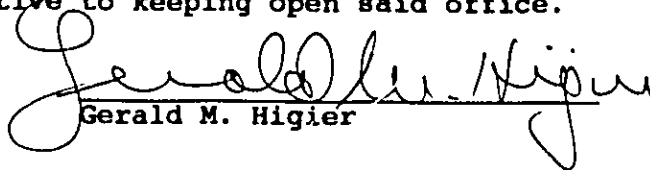
