ARTICLES OF INCORPORATION

OF

International TeleServices, Inc.

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I

The name of the corporation is International TeleServices, Inc. The principal place of business is 2663 E. Sunrise Blvd., #230, Ft. Lauderdale, Florida 33304

ARTICLE II

The period of duration of the corporation is perpetual.
