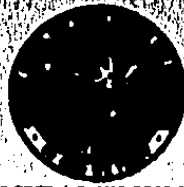

Article I - Name

The name of this corporation is SOUTHEAST TEAM, INC.


