Pursuant to the provisions of Section 607.1007 of the Florida Business Corporation Act, **SHOW ME INCORPORATED**, a Florida corporation (the "Corporation"), adopts the following Amended and Restated Articles of Incorporation (the "Restated Articles"):

1. The name of the Corporation is: SHOW ME INCORPORATED. The date of filing of the original Articles of Incorporation with the Secretary of State of the State of Florida was March 15, 1995 (Document Number: P95000021134). The date of filing of the Amended Articles of Incorporation with the Secretary of State of the State of Florida was October 23, 1996.
2. These Restated Articles were duly adopted by the board of directors without shareholder action and shareholder action was not required.
3. The effective date of these Restated Articles shall be upon the filing of these Restated Articles with the Secretary of State of the State of Florida.
5. The Articles of Incorporation, as amended are hereby amended and restated in their entirety as follows:
