#### ARTICLES OF INCORPORATION

#### ARTICLE I

#### NAME

The name of the Corporation is Stevens Productions, Inc.. The principal office address and the mailing address of said Corporation is 2375 North Smullian Trail Jacksonville, Florida 32217.

#### ARTICLE II

#### **DURATION**

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

#### ARTICLE III

#### **PURPOSE**


