ARTICLES OF INCORPORATION
OF

ARTICLE I -- NAME

The name of this corporation shall be GKC, INC..

ARTICLE II - PRINCIPAL OFFICE

The principal office shall be located at 1303 N. Myrtle Avenue, Suite 11, Clearwater, FL 34615 and the mailing address of the corporation is 2237 Terrace Drive, N., Clearwater, FL 34625.

ARTICLE III -- PURPOSE

This corporation is organized to engage in any activity of business permitted under the laws of the United States or of this State.

ARTICLE IV -- TERM OF EXISTENCE


