I am in receipt of your letter dated July-18, 2000.—I-would like to take a moment-to state.—
Nelson Davis Homes (NDH) corporate business practice and the circumstances surrounding this issue.

NDH has many filing requirements and has always strictly abided to the governing rules associated with those requirements. We file all of our annual reports on time each year. We have always filled the Fl. Dept. of State annual report on time and regret that we did not follow suit in 2000. The only reason our policy was over looked, in this instance, was because we did not receive the preprinted forms that have always been provided in the past. Although I understand that the pre-printed forms are sent as a courtesy reminder of this filing requirement, we have depended on them to arrive to initiate the actions needed in house to renew our corporate standing.

There are three corporations that operate from this office and none of the preprinted forms arrived this year. The moment (06-12-00) I uncovered the oversight I contacted your office. I talked to Mr. Hampton and requested blank forms sent to me as soon as possible so that I could file the required reports. I was told that many of the preprinted forms had failed to be sent out for the filing year 2000. Mr. Hampton also suggested I write a letter explaining the situation and submit it with the forms. I was told that consideration could be given and the fees may be waived. I did this and again I write today for you to reconsider-your demand for additional payment of \$400:00. Thave taken steps to eliminate our dependence on the preprinted forms to file the UBR timely in the future.

With your consideration, given to the situation, I respectfully request that you abate any penalty associated with filing the form past the deadline. I regret any inconvenience that submitted the reports prior to the May 1 due date may have caused your office.
