#### ARTICLES OF INCORPORATION

OF

## ARIRANG, INC.

## Article I - Name

The name of this corporation is ARIRANG, INC.

## Article II - Duration

This corporation shall exist perpetually commencing on the date of execution of these Articles, if they shall be filed with the Department of State within five days after execution, and if not, commencing on the date of such filing.

#### Article III - Purpose

This corporation is organized:

- I. To manufacture, construct, purchase or otherwise acquire and to own, mortgage, pledge, sell, assign, transfer or otherwise dispose of, and to invest in, trade in, deal in and with products, goods, wares, merchandise, real and personal property and services of every kind, class and description.
- 2. To engage in any activity or business permitted under the laws of the United States and of this State, as the same may be from time to time amended.

#### Article IV - Capital Stock

This corporation is authorized to issue **1,000** shares of \$1.00 par value common stock, which shall be designated "Common Shares". No shareholder shall be entitled to preemptive rights.

# Article V - Initial Registered Office and

#### <u>Agent</u>

# Article VI - Initial Board of Directors

This corporation shall have one director initially. The number of directors may be either increased or diminished from time to time by the by-laws but shall never be less than one. The names and addresses of the initial directors of this corporation are:

# Article VIII-By-laws
