ARTICLES OF INCORPORATION

OF

HILITES ON THE BEACH, INC

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I NAME

The name of the corporation shall be:

ARTICLE II PRINCIPAL OFFICE

ARTICLE III SHARES

The number of shares of stock that this corporation is authorized to have outstanding at any one time is:

ARTICLE UII PREEMPTIVE RIGHTS

Furthermore, should any shareholder decide or be forced to sell or dispose of his shares, the corporation and the other shareholders shall have the right of first refusal as to the purchase of those shares.
