# ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, hereby adopts the following Articles of Incorporation:

# <u>ARTICLE I</u>

# Name and Principal Place of Business

The name of the corporation is JaxNet Inc., and the principal place of business is 12128 Banyan Tree Drive, Jacksonville, Florida 32258

### ARTICLE II

# **Duration**

This corporation shall exist perpetually, commencing upon the filing of these Articles with the Secretary of State of the State of Florida.

# ARTICLE III

# Nature of Business

This corporation is organized for the purpose of transacting any or all lawful business.

### ARTICLE IV

### Capital Stock

This corporation is authorized to issue 1000 shares of \$.00 par value common stock which shall be designated "Common Shares."
