NAME

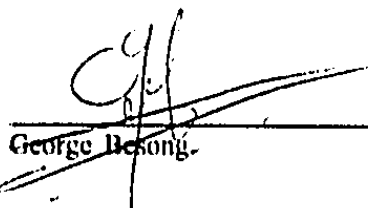

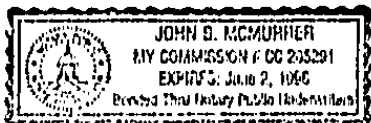

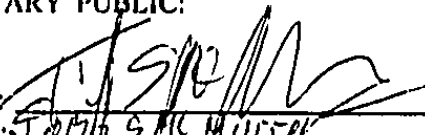
