# ARTICLES OF INCORPORATION

OF

# TOP PERFOREMANS SATELLITE, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Farida Business Corporation Act, hereby adopts the following Articles of Incorporation:

### ARTICLE 1 - NAME

The name of the corporation shall be Top Perforemans Satellite, Inc.

### ARTICLE II - PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be Top Perforement Satellite, Inc., 614 S. Florida Ave., Lakeland, Fl 33801.

### ARTICLE III - DURATION

This corporation shall exist in perpetuity, commencing on March 15, 1995.

# ARTICLE IV - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

### ARTICLE V - CAPITAL STOCK

The number of shares of stock that this corporation is authorized to have outstanding at any one time is 25,000 shares, all of which shall be common shares with a par value of \$1.00.

# ARTICLE VI - PRE-EMPTIVE RIGHTS GRANTED

Each shareholder of any class of stock of this corporation shall be entitled to full preemptive rights to purchase any unissued or treasury shares of the corporation and any securities of the corporation convertible into or carrying a right to subscribe to or acquire any unissued or treasury shares.

# ARTICLE VII - RSTRICTION ON TRANSFER OF SHARES

A restriction on the transfer or registration of transfer of shares is imposed to obligate the shareholder first to offer the corporation an opportunity to acquire the restricted shares, at the price originally paid plus 6% on their investment.

### ARTICLE VIII - INITIAL BOARD OF DIRECTORS

This corporation shall have one (1) director initially. The number of directors may be increased from time to time by the by-laws, but shall never be less than one. The name and address of the initial director of this corporation is, Robert A. Foreman, 614 S. Florida Avenue, Lakeland, Fl. 33801.
