ARTICLE I - NAME

The name of the corporation is C.S.S. STORAGE CORPORATION, located at 1878 S.W. 14th Terrace, Miami, Florida 33145.

ARTICLE II - DURATION

This corporation shall have perpetual existence.

ARTICLE III - PURPOSE

The corporation may engage in any activity or business permitted under the laws of the United States and the State of Florida.
