ARTICLES OF INCORPORATION

OF

ESI Cherokee GP, Inc.

ARTICLE I

The name of the corporation is ESI Cherokee GP, Inc.

ARTICLE II

This corporation's existence shall become effective as of March 15, 1995.

ARTICLE III

The corporation is organized for the purpose of transacting any or all lawful business for which corporations may be organized under the Florida Business Corporation Act of the State of Florida.
