ARTICLE I. CORPORATE NAME

The name of this corporation is: SAVIO INTERIOR
DESIGN, INC.

ARTICLE II. NATURE OF BUSINESS AND POWERS

The general nature of the business to be transacted
by this Corporation is to engage in any and all business
permitted under the laws of the State of Florida.

ARTICLE III. CAPITAL STOCK

The maximum number of shares of stock that this
Corporation is authorized to issue and have outstanding at
any one time is 1,000 shares of common stock (having a par
value of \$1.00 per share). All shares issued shall be
fully paid and nonassessable.

ARTICLE IV. TERM OF EXISTENCE

This Corporation shall have perpetual existence.

ARTICLE V. BOARD OF DIRECTORS

This Corporation shall have one Director initially. The number of directors may be increased or diminished from time to time by By Laws adopted by the stockholders, but shall never be less than one.

ARTICLE VI. DESIGNATED AGENT AND INITIAL DESIGNATED OFFICE


ARTICLE IX. AMENDMENTS
