

ARTICLE I

The name of this corporation is WILCOX ENGINES, INC.

ARTICLE II - Name

This corporation shall exist in perpetuity.

ARTICLE III - Duration

This corporation is organized for the purpose of engaging in any activity or business permitted under the laws of the State of Florida.

ARTICLE IV - Capital Stock

This corporation is authorized to issue seven thousand five hundred (7,500) shares of One (\$1.00) Dollar par value common stock, which shall be designated "common shares".

ARTICLE V - Initial Registered Office and Agent

The street address of the initial registered office of this corporation is 6257 Winding Lake Drive, Jupiter, Florida 33458, and the name of the initial registered agent of this corporation at that address is ROBERT C. WILCOX.

ARTICLE V - Principal Office Address

The principal place of business of this corporation shall be located at 6257 Winding Lake Drive, Jupiter, Florida 33458, or at such places within or without the State of Florida as the Board of Directors shall by appropriate action hereafter from time to time determine.

ARTICLE VI - Directors

The business of this corporation shall be conducted and managed by a Board of Directors and such Board of Directors shall consist of not less than one (1).

The qualifications, time and place of election and term of office of each Director shall be provided for in the By-Laws of the corporation.
