SHARES OF STOCK

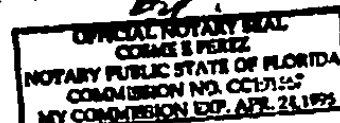

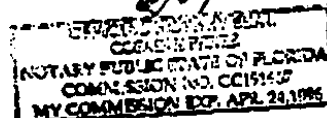
