THE UNDERSIGNED, DEBORAH SCHNEIDER, horoby executes this document for the purposes of becoming incorporated under the laws of the state of Florida, and forming a corporation under the following proposed Certificate of Incorporation:

# ARTICLE I

The name of this Corporation is PediaDent, Inc.

#### ARTICLE II

The general nature of the business to be transacted by the Corporation is as follows:

The Corporation may engage in any activity or business permitted by the Laws of the United States and of this State.

#### ARTICLE III
