ARTICLES OF INCORPORATION

OF

NOVA HAIR & NAIL SALON, INC.

I, THE UNDERSIGNED SUBSCRIBER OF THESE ARTICLES OF INCORPORATION, NATURAL PERSON, COMPETENT TO CONTRACT, AND DESIRING TO FORM A CORPORATION UNDER THE LAWS OF THE STATE OF FLORIDA, HEREBY CERTIFY AS FOLLOWS:

ARTICLE I

THE NAME OF THE CORPORATION IS:

NOVA HAIR & NAIL SALON, INC.

ARTICLE II

THE CORPORATION MAY ENGAGE IN ANY ACTIVITY OR BUSINESS PERMITTED UNDER THE LAWS OF THE UNITED STATES OF AMERICA AND THE STATE OF FLORIDA.

ARTICLE III


