ARTICLE I. NAME

The name of this corporation is TASKER FAMILY CORPORATION (the "Corporation").

ARTICLE II. PRINCIPAL OFFICE

ARTICLE III. DURATION

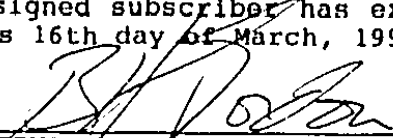
ARTICLE IX. INDEMNIFICATION

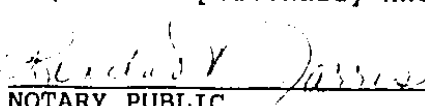
