ARTICLES OF THEORPORATION DAYID DOWNING, THE.



We, the undersigned, all being suffuria, do hereby agree for ourselves, under the laws of the State of Florida, Florida Statute 607 of seq. and the provisions therein providing for the formation, rights, liabilities, privileges, benefits, and obligations conferred and imposed by said laws on corporations for prefit, do hereby subscribe to and adopt the Articles set forth herein.

ARTICLE ONE: Namo

The name of this Corporation shall be David Downing, Inc.

ARTICLE TWO: Duration

David Downing, Inc. shall have perpetual existence.

ARTICLE THREE: Purpose

The general and specific purposes for which David Downing, Inc. is organized are to:

- A. Engage in the business of Musical Entertainment.
- B. Purchase, sell, receive, take by grant, gift or devise, bequest or otherwise, own, hold, improve, through experimentation in full or by an interest in related entities and development designed and appropriate for intra-structural development.
