ARTICLES OF INCORPORATION OF ST. ANDREWS RESTAURANT, INC.

WE, the undersigned Incorporators of this Corporation, pursuant to Chapter 607, Florida Statutes, as amended, adopt the following Articles of Incorporation:

ARTICLE I

The name of the Corporation is:

ARTICLE II

The general nature of the business to be conducted by this Corporation shall be to engage in operating a restaurant company, to acquire by purchase, lease or otherwise, lands and interest in lands, and to own, hold, improve, develop, and manage any real estate so acquired, and to erect, or cause to be elected, on any land owned, held or occupied by the Corporation, buildings or other structures, with their appurtenances, and to manage, operate, lease, rebuild, enlarge, alter or improve any buildings or other structures, now or hereafter erected on any land so owned, held or occupied, and to encumber or dispose of any land or interest in land, and any buildings or other structures, and any stores, shops, suite, rooms or part of any buildings or other structures, at any time owned or held by the Corporation.

To acquire by purchase, lease, manufacture, or otherwise, any personal property deemed necessary or useful in equipment, furnishing, improvement, development, or management of any property, real or personal, at any time owned, held or occupied by the Corporation, and to invest, trade, and deal in any personal property deemed beneficial to the Corporation, and to encumber or dispose of any personal property at any time, owned or held by the Corporation; and
