ARTICLES OF INCORPORATION OF

STATE OF FLORIDA

SOLAR CABLE SYSTEMS, INC.

COUNTY OF OKALOOSA

The undersigned acting as incorporators of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I

The name of the Corporation is Solar Cable Systems, Inc.

ARTICLE II

The objects and purposes for which this corporation is organized and the nature of the business and/or businesses to be carried on by it, are stated and declared to be as follows:

Sales, Installation and Maintenance of Cable Systems and other business interests the Corporation may wish to enter.

ARTICLE III

The Corporation shall have a perpetual existence.

ARTICLE IV

The location and post office address of the registered office and also principal office is:

ARTICLE V

ARTICLE VI

The total authorized number of shares is 100,000 shares of capital stock with no par value.

All stock of this association shall be voting stock and each shareholder shall have the right of one vote for each share outstanding in his/her name.

ARTICLE VII

The amount of paid-in capital with which this Corporation shall begin business is \$100.00 paid in cash.

#### ARTICLE VIII

The names of the first directors and post office addresses follow: GEOFFREY W. MOORE, Pres. 1106 Green Tree Court FL. Walton, FL  
JAYSON R. CRUTCHFIELD, V.P. 1106 Green Tree Ct. FL. Walton, FL  
Unless and until otherwise provided by the by-laws and corporate powers of this Corporation shall be vested in and the business and affairs of the Corporation shall be managed by the above managing directors.

Unless and until otherwise provided in the by-laws the directors shall hold office indefinitely or until their successors have been duly elected and qualified, but the number, classification, qualification, term of office, manner of election, times and places of meetings, and the powers and duties of directors shall be same as fixed in the by-laws. The officers as indicated above shall have authority to make and alter by-laws subject only to the power of the shareholders to change or repeal the by-laws so made.

#### ARTICLE IX

The names and post office address of the incorporators and the number of shares subscribed are:

Geoffrey W. Moore	100 shares
Jayson R. Crutchfield	100 shares

#### ARTICLE X

The Corporation may purchase and redeem its own shares in the manner and under the conditions provided in Florida Statutes of the Business Corporations Law. Such shares so purchased shall be authorized by law, or may be cancelled and the capital stock reduced as the Officers may, from time to time, designate.

#### ARTICLE XI

This Corporation claims and shall have the benefit of the provisions of the Florida Business Corporations Law with reference to compromise arrangements and reorganizations.

#### ARTICLE XII

The Corporation shall have authority to acquire shares in other Corporations or to sell shares in this Corporation to other Corporations or to exchange its shares for shares of other Corporations or for assets of other Corporations.

#### ARTICLE XIII

The Corporation may purchase, either for cash or on credit, any personal property of real estate, improved or unimproved, to be used by said Corporation in the pursuit of its business or to hold for future use or for any business it may desire, and it may sell any property so purchased, either for cash or for credit. The Corporation may borrow or lend money, under such terms and conditions as the Officers shall designate.

#### ARTICLE XIV

No sale or transfer of stock of this Corporation shall be made by any owner thereof, except as follows:

The proposed transferrer shall notify the President of the Corporation in writing of his desire to sell and transfer said stock, stating the number of shares he desires to sell, the price for which he proposes to sell and the name and address of the proposed purchaser.

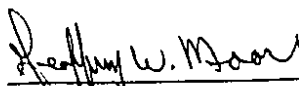
The President shall within three legal days from receipt of said notice of intention to sell, give notice in writing to all other shareholders of the Corporation, stating the names of the proposed seller and purchaser, the number of shares desired to be sold and the price thereof.

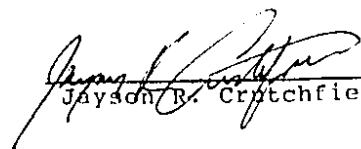
Any other shareholder interested shall signify to the President of his desire to purchase the stock proposed to be sold at the same price and the shareholder first so notifying the President shall be entitled to purchase same and have same transferred to him.

If the President receives no such acceptance within fifteen (15) days after the mailing of the above notice, then the proposed seller shall be permitted to transfer the stock to the proposed purchaser at the stated price.

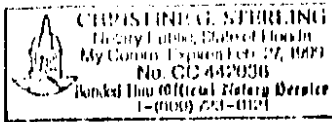
#### ARTICLE XV
