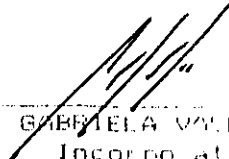
The undersigned do hereby state for purposes of the Florida Business Corporation Act, Chapter 607, Florida Statutes, that the following articles of incorporation:

- FIRST: The name of the corporation is: CAPPADORO GROUP, INC., (the "Corporation").
- SECOND: The Principal office address and mailing address of the Corporation is: 9445 Fountainebleau Blvd., Suite # 202, Miami, Florida 33172.
- THIRD: The Corporation is authorized to issue 10,000 shares of common stock, par value .01 per share.

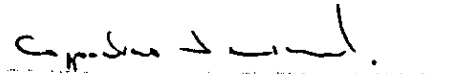
