The undersigned do hereby associate themselves together for the purpose of forming a corporation under the laws of the State of Florida under the corporate name VICTORY HOMES OF SOUTHWEST FLORIDA, INC. and hereby set forth and declare:

CHARTER

Article 1

The name of the corporation shall be Victory Homes of Southwest Florida, Inc. and shall be located in Fort Myers, Lee County, State of Florida.

Article 2

The corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

Article 3

The amount of the capital stock of this corporation shall be One Hundred (100) shares with a par value of \$ 5.00 per share. Said stock shall be non assessable and to be held, sold and paid for at such time and in such manner as the Board of Directors may from time to time determine. All of the stock shall be common stock.

Article 4

The corporation shall commence business on filing with the Secretary of State.

Article 5

The corporation shall have perpetual existence, except that the same may be dissolved, as provided by law.

Article 6

The principal place of business of the corporation shall be 16520 South Tamiami Trail, Suite 207, Fort Myers, Florida 33908.

Article 7

The corporation shall have a Board of one (1) Director and may be increased to not more than five (5) Directors and the number of Directors each year may be determined by the Shareholders at their annual meeting.

Article 8

The officers by whom the business of the corporation shall be a President, who shall be a Director, and any other officers as determined by the Board of Directors. The name and Post Office address of the corporate officer and Director until his successor is elected is:

The amount of indebtedness or liability to which the corporation at any time may subject itself shall be unlimited.

Article 11

The street address of the initial registered office of this corporation shall be 16520 South Tamiami Trail, Suite 207, Fort Myers, Florida 33908 and the name of the initial registered agent of this corporation at that address is WILLIAM NUNEZ.

Article 12

The initial Bylaws of this corporation shall be adopted by the Board of Directors. The Bylaws may be amended from time by either the shareholders or the director.

Art icle 13

Any subscriber or shareholder present at any meeting, either in person or by proxy, and any directors present in any meeting of the Board of Directors shall conclusively be deemed to have received proper notice of such meeting unless he shall make objection at such meeting to any defect or insufficiency of notice.

Article 14

Each director and officer of the corporation shall be indemnified by the corporation for all costs and expenses reasonably incurred which were for the benefit of the corporation.

In all other respects, the original articles of incorporation

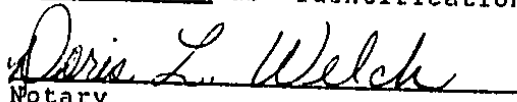
