OF

ARTICLE I

The name of this corporation shall be 5775 CORP

ARTICLE II

This corporation shall have perpetual existence.

ARTICLE III

The general nature of the business to be conducted by this corporation is to engage in any activity or business permitted under the laws of the United States and of Florida.

ARTICLE IV

The maximum number of share which this corporation is authorized to have outstanding at any time is 100 share of common stock having no par value. The Board of Directors may authorize the issuance of such stock to such persons upon such terms and for such consideration as they may deem appropriate. The consideration may include money or other property, which property shall be received at a just valuation to be fixed by the Board of Directors of this corporation.

The initial Board of Directors shall consist of one member. The number of directors may be increased from time to time by vote of the stockholders, but in no case shall the umber of directors be less than one nor more than five.




