ARTICLES OF INCORPORATION OF BAYMEADOWS CABLE, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Acts hereby adopts the following Articles of Incorporation.

ARTICLE_I-NAME
