Article I - Name
and Principal Place of Business

The name of this corporation is METZ TWO, INC., and its principal place of business is 2136 S. Atlantic Avenue, Daytona Beach, FL 32118.

Article II - Duration

This corporation shall have perpetual existence.

Article III - Purposes

The general purposes for which this corporation is initially organized are to own personal property; to own, hold, lease, improve and develop real estate; engage in any type of lawful business; lend or borrow money, and to draw, make, accept, discount and issue promissory notes, bills of exchange, and other negotiable instruments, and to secure the same by mortgage or otherwise; to have offices and officers, agents and agencies in the State of Florida or in any other of the states of the United States, or any dependencies of the United States, or in foreign countries; and to exercise generally such powers as may be incident to or convenient for the purposes and businesses of the corporation and to engage in any activity or business permitted under the laws of the United States and the State of Florida, it being expressly provided that the foregoing enumeration of specific powers shall not be held to limit or restrict the general powers of the corporation.

Article IV - Capital Stock

The maximum number of shares of stock which this corporation is authorized to have outstanding at any time shall be 1000 shares

of common voting stock with a par value of \$1.00 per share.
All stock issued shall be fully paid.

Article V - Initial Registered Office and Agent

The street address of the initial registered office of this corporation is as follows: 2136 S. Atlantic Avenue, Daytona Beach, FL 32118 and the name of the initial registered agent of this corporation at that address is: Ann L. Metz.

Article VI - Initial Board of Directors


Article VIII - Indemnification
