The undersigned, acting as incorporators of a Florida corporation under the Florida Professional Service Corporation Act, Chapter 621 of the Florida Statutes, hereby adopt the following Articles of Incorporation for Such Corporation:

ARTICLE I

NAME

The name of the corporation is: Leifert & Drill, P.A.

ARTICLE II

PRINCIPAL OFFICE AND MAILING ADDRESS

The principal office of the Corporation is the International Building, Penthouse West, 2455 East Sunrise Boulevard, Fort Lauderdale, Florida 33304.

ARTICLE III

PURPOSE

The Corporation is organized for the purpose of engaging in the practice of law as governed by the Supreme Court of the State of Florida, and taking all actions that are necessary and proper in connection with that practice.

ARTICLE IV

PURPOSE

The Corporation is authorized to issue One Hundred (100) shares of common stock, One Dollar (\$1.00) par value per share.
