ARTICLES OF INCORPORATION

OF

J. SILVER OF DELRAY BEACH, INC.
(A Corporation for Profit)

The undersigned, with others being desirous of forming a corporation, for profit, under the provisions of Ch. 607.0202(B) of the Florida Statutes, do agree to the following:

ARTICLE I. NAME

The name of the corporation is J. SILVER OF DELRAY BEACH, INC.

ARTICLE II. DURATION

This corporation shall have perpetual existence.

ARTICLE III. PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE IV. CAPITAL STOCK

This corporation is authorized to issue 7,500 shares of \$1.00 par value, common stock.

ARTICLE V. INITIAL PRINCIPAL OFFICE

The address of the initial principal office of the corporation and the mailing address is 1463 S. Congress Avenue, Delray Beach, FL 33444.

ARTICLE VI. INITIAL REGISTERED OFFICE AND AGENT

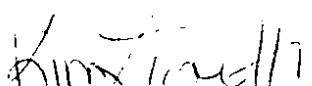
