ARTICLES OF INCORPORATION

OF

The under igned natural person, having capacity to contract, and acting as the Incorporator of this Corporation under the Florida General Corporation Act adopts the following Articles of Incorporation for such Corporation, to-wit:

ARTICLE ONE: NAME AND PRINCIPAL OFFICE
