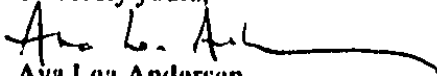

**ARTICLES OF INCORPORATION  
OF

**ARTICLE I - NAME**

The name of the corporation is: KEY WEST WRECKERS L & L, INC.

**ARTICLE II - DURATION**

This corporation shall exist perpetually unless sooner dissolved according to law, commencing on the date of the filing of these Articles of Incorporation.

**ARTICLE III - PURPOSE**

The general nature of the business and the objects and purposes to be transacted and carried on are to do any and all things allowed and permitted to be done by corporations under the Statutes of the State of Florida, and to do any and all of the things hereinafter mentioned as fully and to the same extent as natural persons might or could do, to-wit:

(a) To promote the leather/levi life-style as a form of entertainment and to express that life-style through social activities; to encourage brotherhood, support charitable causes, promote understanding in judging others, and promote the equal treatment of all individuals regardless of race, religion or national origin; to advance individual knowledge, safety, and technique of the leather/levi life-style; to raise and collect funds to ensure a stable organization and for the financial support of chosen charities, but not to generate a profit; and to operate as a not for profit organization.

(b) Generally, to make and perform contracts of any kind and description, and for the purpose of attaining any of the objects of the corporation, to do and perform any other acts and things, and to exercise any and all powers which a co-partnership or natural person could do and exercise, and which are now, or hereafter may be authorized by law, and generally do and perform any and all things necessary or incidental to the performing or carrying out of the powers hereinabove specifically delegated or implied.

**ARTICLE IV - INITIAL REGISTERED OFFICE AND AGENT**
