OF

I, the undersigned, being of legal age and a natural person, do hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

ARTICLE I

The name of this corporation shall be T. CURTMOC FINE ARTS, INC., and the initial address of this corporation shall be 1333 N.E. 119th Street, N. Miami, Florida 33161.

ARTICLE II

This corporation may engage in any activity or business permitted under the laws of the State of Florida.


