ARTICLE I - NAME

The name of this corporation is I.V.M. Business, Inc.

ARTICLE II - PRINCIPAL OFFICE

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transaction any and all lawful business.

ARTICLE IX - INDEMNIFICATION

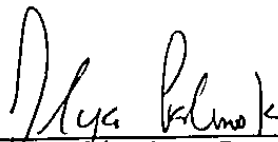
The corporation shall indemnify an Officer or Director, or any former Officer or Director, to the full extent permitted by law.

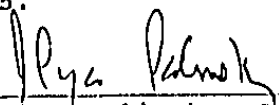

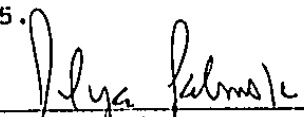
