ARTICLES OF INCORPORATION

OF

NEPTUNE REALTY, INC.

ARTICLE ONE - NAME

The name of this corporation is Neptune Realty, Inc. (hereinafter referred to as the "Corporation").

ARTICLE TWO - DURATION
