

**ARTICLES OF INCORPORATION
OF
Jacksonville Rental & Construction, Inc.**

The undersigned, for the purpose of forming a corporation for profit under the laws of the State of Florida, hereby adopts the following Articles of Incorporation:

**ARTICLE I
Name**

The name of the corporation is Jacksonville Rental & Construction, Inc.

**ARTICLE II
Duration**

This corporation shall exist perpetually, Articles are executed and acknowledged, except that if they are not filed by the Department of State of the State of Florida within five (5) days, exclusive of legal holidays, existence shall commence upon the filing by the Department of State.

**ARTICLE III
Nature of Business**

This corporation is organized for the purpose of transacting any or all lawful business.

**ARTICLE IV
Capital Stock**

(a) Authorized Capital. The maximum number of shares of stock which this corporation is authorized to have outstanding at any one time is 500 shares of common stock having a par value of \$1.00 per share.

(b) Preemptive Rights. Shareholders shall have no preemptive rights.

(c) Cumulative Voting. Cumulative voting shall not be permitted.

(d) Restrictions on Transfer of Stock. The shareholders may, by bylaw provisions or by shareholders' agreement recorded in the minute book, impose such restrictions on the sale, transfer or encumbrance of the stock of this corporation as they may see fit.

ARTICLE V
Initial registered Office and Agent

The street address of the initial registered office of the corporation is 6840 State Road 16, St. Augustine, Florida 32092, and the name of the initial registered agent of this corporation at that address is David R. Shields, the principal officer and mailing address is 6840 State Road 16, St. Augustine, Florida 32092.

ARTICLE VI
Directors

(a) Number. This corporation shall have one (1) director initially. The number of directors may be increased or diminished from time to time by the bylaws, but shall never be less than one.

(d) Indemnification. The board of directors is hereby specifically authorized to make provisions for indemnification of directors, officers, employees and agents to the full extent permitted by law.

ARTICLE VII
Bylaws

The initial bylaws of this corporation shall be adopted by the directors. Bylaws shall be adopted, altered, amended, or repealed from time to time by either the shareholders or the board of directors, but the board of directors shall not alter, amend or repeal any bylaw adopted by the shareholders if the shareholders specifically provide that such bylaws is not subject to amendment or repeal by the directors.



This corporation reserves the right to amend or repeal any provision contained in these Articles of Incorporation, and any right conferred upon the shareholders is subject to this reservation.


