ARTICLE I - NAME

The name of this corporation is **FIRST GLOBAL CONNECTION, INC.**
The principal office and mailing address of this corporation is :

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of the filing of these Articles with the Department of State.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.
