The undersigned, being natural persons, competent to contract and for the purpose of forming a corporation for profit under the Florida General Corporation Act, do hereby adopt the following articles of incorporation:

ARTICLE !

NAME

The name of the Corporation is:

HAMILTON SPECIALTY, INC.

ARTICLE !!

CORPORATION DURATION

This Corporation shall exist perpetually unless sooner dissolved according to law.

ARTICLE III

PURPOSE OR PURPOSES

The purpose or purposes for which this Corporation is organized are to engage in any or all lawful business or trade which can, in the opinion of the Board of Directors of the
