ARTICLES OF INCORPORATION

OF

GULF AREA REALTY, INC.

EFFECTIVE DATE

ARTICLE 1 - NAME:

The name of this corporation is Gulf Area Realty, Inc. (hereafter referred to as the "Corporation").

ARTICLE II - DURATION: AS The corporation shall exist perpetually, commencing March 1, 1995 (which lie the date of two cylintion and cocknewledgement) and the lie of the corporation.

ARTICLE III - PURPOSE:

The corporation is organized for the purpose of transacting any or all lawful business not inconsistent with the laws of the State of Florida.

ARTICLE IV - CAPITAL STOCK:

ARTICLE VI - INITIAL PRINCIPAL OFFICE, REGISTERED OFFICE AND AGENT:

ARTICLE VII - INITIAL BOARD OF DIRECTORS:

The Corporation shall have four (13) directors initially. The number of directors may be either increased or diminished from time to time by the by-laws but shall never be less than one. ARTICLE VILT - INCORPORATION:

ARTICLE IX " BY"LAWS:

The power to adopt, alter, amend, or repeal the by-laws shall be vested in the Board of Directors and the shareholders.
