ARTICLE 1

Name: The name of the Corporation is KUSKIN CHIROPRACTIC CENTER, P. A.

ARTICLE 2

Duration: The period of duration of this corporation is perpetual.

ARTICLE 3

Purpose and Powers: This corporation may engage in any activity of business permitted under the laws of the United States and the State of Florida.

Specific Nature  
of Business:

Kuskin Chiropractic Center, P.A. is a chiropractic center in which problems with the human musculoskeletal system will be analyzed and corrected. This will be accomplished by the use of XRays, exercises, specific chiropractic adjustments, and any other diagnostic or correctional modalities the treating chiropractor feels are necessary to enhance the patients health.

ARTICLE 4

Capital Stock: The aggregate number of shares which this corporation shall have authority to issue is one thousand(1,000) shares of common stock, having a par value of one dollar (\$1.00) per share.

ARTICLE 5

Pre emptive Rights: Every stockholder, upon the sale for cash of any new stock of this corporation of the same kind, class, or series as that which he already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.




