ARTICLES OF INCORPORATION
OF

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I - NAME

The name of this corporation is:

COMMERCIAL MARINE TRAINING SYSTEMS, INC.

ARTICLE II - DURATION

This corporation shall have perpetual existence, commencing upon the filing of the Articles of Incorporation with the Secretary of State of the State of Florida.

ARTICLE III - PURPOSE

The general purposes for which the corporation is organized are:

1. To engage in the business of:

Training and education for boating safety, and preparation for Coast Guard licenses.

2. To transact any other lawful business for which corporations may be incorporated under the Florida Business Corporations Act.

3. To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.

ARTICLE IV - CAPITAL STOCK

The aggregate number of shares which the corporation is authorized to issue is ten thousand (10,000). Such shares shall be of a single class and shall have a par value of ONE DOLLAR (\$1.00) per share. There shall be 500 shares issued initially.

ARTICLE V - REGISTERED OFFICE AND AGENT

The street address of the initial principal office of this corporation is: **4080 Gulfview Drive, Spring Hill, Florida 34607**; the mailing address of this corporation is **4080 Gulfview Drive, Spring Hill, Florida 34607**, with the privilege of having branch offices at any other place within the State of Florida. The name of the initial Registered Agent of this corporation is **KENNETH L. WARNSTADT**, with a street address of: **11473 Stringer Rd., Brooksville, FL 34601**.

ARTICLE VI - MANAGEMENT OF THE CORPORATION

The business of the corporation shall be managed by the shareholders of the corporation rather than by a Board of Directors.

(a) The shareholders of this corporation shall be deemed directors for the purpose of the provision of chapter 607, Florida Statutes.

(b) Any action of the shareholders may be taken without a meeting if consent in writing setting forth the action so taken shall be signed by all persons who would be entitled to vote upon such action at a meeting and filed with the Secretary of the corporation as part of the corporate records.

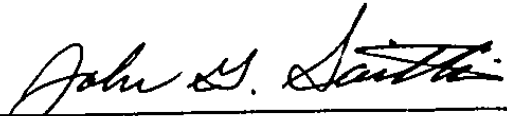

These Articles of Incorporation may be amended in the manner provided by law.

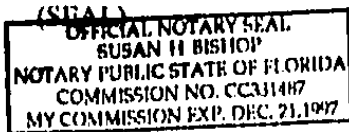
