#### **ARTICLE I. NAME**

The name of the corporation is 'THE LAW OFFICES OF MONA NOUR P.A..

#### **ARTICLE II. PURPOSE AND NATURE OF BUSINESS**

The purpose of the Corporation and the nature of its business are as follows:

To engage in the practice of Federal Agency Law and more especially in Immigration law and to render such services as may be ancillary to the foregoing. The corporation may purchase and own real and personal property necessary or appropriate for rendering its professional services any may invest its funds in real estate, mortgages, stocks, bonds, and any other type of investments, all in accordance with the provisions of F.S.A. Chapter 621.

#### **ARTICLE III. CAPITAL STOCK**

The maximum number of shares of stock that the Corporation is authorized to have outstanding at any one time is 100 shares having no par value. Such shares shall be of a single class of common stock. None of the shares of the Corporation may be issued to anyone other than an individual who is duly licensed to practice Federal Agency Law in the State of Florida and is an active member of a State Bar in good standing.

#### **ARTICLE IV. DURATION**

The corporation shall have perpetual existence.

#### **ARTICLE V. ADDRESS AND AGENT**

The street address of the principal and initial registered office of the Corporation is 4045 NW 16th Street Suite 211, Lauderhill, Florida, 33313, and the name of its initial registered agent is Mona Nour. The Board of Directors may from time to time move the office to any other address in the State of Florida and change the registered agent.

#### **ARTICLE VI. DIRECTORS**

The corporation shall be managed by a Board of Directors of at least one (1) Director. No person shall serve as a Director of the Corporation unless the person is duly licensed to practice Federal Agency Law in the State of Florida and is an active member of a State Bar in good standing. The Directors shall be elected by the shareholders of the Corporation. The name and street address of each person who is to serve as a member of the initial Board of Directors is as follows:

#### ARTICLE VIII. RESTRAINT ON ALIENATION

No shareholder may sell or transfer his shares in the Corporation except to another individual who is eligible to be a shareholder of the Corporation under Florida law.

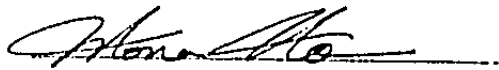
#### ARTICLE IX. DISQUALIFICATION

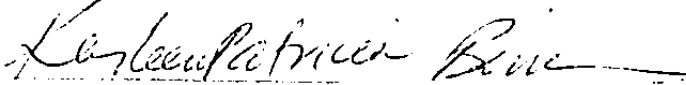

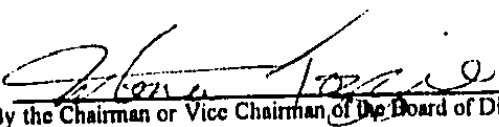
