ARTICLE I : NAME

The name of the corporation is :

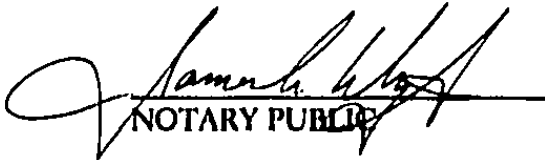
