**ARTICLES OF INCORPORATION**

The undersigned incorporator delivers these Articles of Incorporation in order to form a corporation under the Florida Business Corporation Act.

**ARTICLE I**

**Name**

The name of the Corporation shall be CLASSIC MANAGEMENT, INC.

**Principal Office**

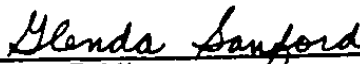
