Articles of Incorporation:

ARTICLE I

The name of this corporation shall be:

T & S ACCOUNTING & FINANCIAL SERVICES, INC.

ARTICLE II

The corporation may engage in any activity or business permitted under the laws of
United States and of the State of Florida.

ARTICLE III

The maximum number of shares of stock that this corporation is authorized to have
outstanding at any time shall be as follows:

One Thousand (1000) shares of common
stock at \$1.00 per share, par value.

The entire voting power of the corporation shall be vested in the common stockholders,
and each share of common stock shall be entitled to one vote, as shall be more fully

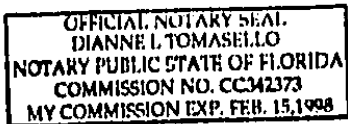
