# ARTICLES OF INCORPORATION

# BARTANO EXHIBITS, INC.

The undersigned subscribers of these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation under the laws of the State of Florida.

#### ARTICLE I

The name of the corporation is BARZANO EXHIBITS, INC.

### ARTICLE II
