I, THE UNDERSIGNED, DESIRE TO BECOME A BODY CORPORATE AND DO HEREBY MAKE AND FILE THESE ARTICLES OF INCORPORATION FOR A PROPOSED CORPORATION PURSUANT TO THE LAWS OF FLORIDA, AND TO THAT END DECLARE:

**ARTICLE I - NAME**
