# ARTICLE I

The name of the Corporation is J & M Trucking of Auburndale Inc.

# ARTICLE II PURPOSES

The nature of the business and, the objects and purposes proposed to be transacted, promoted and carried on, are to engage in any lawful act or activity for which corporations may be organized under the laws of the United States and under the general Corporation Law of the State of Florida.

### ARTICLE III CAPITAL STOCK

The maximum number of shares of stock that this Corporation is authorized to have issued and outstanding at any time is 10,000 shares of par value common stock, with a par value of one dollar per share.

### ARTICLE IV TERM

The initial registered and principal office of the Corporation is 1021 Lake Alfred Rd. Auburndale, Florida 33823, and the initial registered agent at said address is Mavis Singleterry. The Board of Directors may from time to time move the principal office to any other address in the State of Florida.

### ARTICLE VII INITIAL BOARD OF DIRECTORS

## ARTICLE X INDEMNIFICATION

This corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.
