BY THESE ARTICLES the incorporator forms a corporation under the Business Corporations Act:

1. NAME. The name of this corporation is Birdsong Successors, Inc.
2. PRINCIPAL OFFICE. The address of the principal office of this corporation is 6508 E. Fowler Avenue, Temple Terrace, Florida 33617 and its mailing address is the same.
